THE CITY

The city of Melfort is a small community with a population of approximately 5800. Melfort offers good shopping, entertainment and excellent restaurants, including fast food options.

A large health facility provides for people in various stages and levels of health needs. There is a full complement of doctors, specialists coming in from Saskatoon to meet different needs. C-scan equipment has recently been put in place and ultra sound imaging is available. A heli pad is next to the hospital for emergency helicopter service. There is senior housing and care facilities. A new eye doctor facility employing three optometrists.

This city is supported by a large farming community and employment in government departments. A large manufacturer of farm machinery is in St Brieux, which employs many local residents.

Melfort is the gate way to great fishing, hunting, and other recreational activities to the north of the city.
